Subject: Phase 1	Hydro One Networks Inc. (HONI) Funding –Community Benefit Projects,

### Recommendation

Direct Administration to proceed with the implementation of Phase 1 of the recommended HONI Community Benefit Projects; and

Direct Administration to bring phased reports to Council in line with the Community Support Agreement milestones being met with respect to planned spend and projects, as presented at the March 19, 2024 Council meeting.

### Background

At the Regular Council Meeting held on August 15, 2023, Administration brought forward a report for information regarding the Community Support Agreement (CSA) between Hydro One Networks Inc. (HONI) and the Municipality of Lakeshore (Lakeshore). As part of the CSA, HONI is committed to providing funding specifically related to the Community Benefits Contribution based on various hydro infrastructure related project milestones to help assist with any potential impacts these projects will have on the community.

Based on the CSA, the Community Benefit Contribution will focus on community projects related to recreation and culture. These may include the following:

- Community development projects like community centres and/or hubs;
- Park development and/or redevelopment;
- Community based projects including donation and collection programs, education programs, etc.; and
- Projects that will have the ability to showcase the partnership between Lakeshore and HONI.

The agreement outlines that the HONI payments for the Community Benefit Contribution will be made at project milestones such as public filing of the Environmental Assessment (EA), commencement of construction, and completion of construction.

Based on the current HONI project timelines, the Community Benefit Contribution funds can be phased as follows:

## (i) Phase 1

Total = \$ 1,877,589.00 (Milestones currently met)

- Chatham to Lakeshore Line notice of commencement of EA
- Chatham to Lakeshore Line commencement of construction
- Longwood to Lakeshore Line notice of commencement of EA

## (ii) Phase 2

Total= \$256,035.00 (Project milestones anticipated to be met by end of 2025)

• Chatham to Lakeshore Line completion of construction

- (iii) **Phase 3** (Project milestones anticipated to be met by end of 2027) *Total* = **\$882,759.00** 
  - Longwood to Lakeshore Line commencement of construction
- (iv) **Phase 4** (Project milestones anticipated to be met by end of 2030) *Total* = \$2,385,348.00
  - Longwood to Lakeshore Line completion of construction
  - Windsor to Lakeshore Line notice of commencement of EA
  - Windsor to Lakeshore Line commencement of construction
  - Phase 2 of Longwood to Lakeshore Line commencement of construction
- (v) Phase 5 (Project milestones anticipated to be met by 2035)*Total* = \$398,276.00
  - Phase 2 of Longwood to Lakeshore Line completion of construction
  - Windsor to Lakeshore Line notice of completion of construction

The area impacted for Chatham to Lakeshore Line and Longwood to Lakeshore Line (Phase 1 & Phase 2) will be the Comber Area. This was determined through the EA process for both of those projects.

The alignment of the Windsor to Lakeshore Line and the associated impacted community has not been finalized and will be determined during the Environmental Assessment (EA) process for that project.

## Comments

Based on the impact to the Comber community, a list of potential projects was provided to Council in the August 15, 2023 report:

- Build out of the new park in the Tracey Subdivision in Comber;
- Garbage receptacles, benches, community plantings and features along Main Street in Comber;
- Placement and/or replacement of Community Signage in Comber;
- Projects that consider the creation of community gathering locations, public squares, community gardens, placement of community benches, and gardens; and
- Placement and/or replacement of asphalt pathways/trails in Comber Community Park and/or within the community.

In addition to the above, the Municipality provided an opportunity for public feedback and to obtain ideas related to potential community-based projects. The call for submissions was advertised in the September 2023 edition of the Lakeshore Splash newspaper, on the Municipality's website, and through the Municipality's social media channels including a paid Facebook advertisement geotargeting residents in Comber and Woodslee (expected impacted community of Lakeshore to Windsor Line to be determined through the EA process). Below is a summary of projects that have been received for consideration through online submissions, received petitions and recommendations from Administration:

It should be noted that the majority of these projects will be tendered and will require Council approval for award.

Other received project ideas that may be considered for future phasing of potential community benefit projects that are outside of Phase 1 include as follows:

- New park in the Mullins Drive/Oriole Park Drive area with green space
- Libro Community Centre/Millen Park Redevelopment
- Woodslee Memorial Park upgrades
- Dog park in Woodslee
- Tree planting and forestation program for the Woodslee community
- Streetscaping along main road in Woodslee
- Active transportation and pedestrian connectivity
- Community programs
- Centennial Park upgrades in Puce
- New Park for the Seasons Subdivision in Belle River
- Belle River High School Track Partnership with GECDSB
- Lakeview Park outdoor electrical upgrades in Belle River
- Stoney Point Soccer program support to reduce and/or eliminate user fees
- Lakeshore Green Energy Pickleball Centre for River Ridge Park or ATRC

In addition, below is a list of received project ideas from the public that would not be eligible for funding through the CSA with HONI:

- Fibre service expansion
- South Middle Road re-paving and ditch enclosure
- Lakeshore Road 125 paving

### **Others Consulted**

The public was consulted for project ideas related to the various communities.

### **Financial Impacts**

In accordance with HONI project milestones and the agreed upon CSA funding, it should be noted that these timelines may be subject to change as project planning and development proceeds by HONI. The Municipality has confirmed with HONI that the Municipality is entitled to receive Community Benefit Contribution funds in the amount of \$1,877,589 which may be used towards Phase 1 projects.

Administration will bring forward future reports to council regarding funding updates and potential community projects for remaining phases as per the completion of milestones.
