Background

This report provides an overview of by-laws and policies adopted by Council in 2024.

Comments

Council adopted 112 by-laws in 2024. This included:

- 14 by-laws to authorize agreements
- 3 by-laws to amend agreements
- 30 by-laws pursuant to the *Planning Act*
 - o Zoning By-law Amendments 20
 - Part Lot Control 4
 - Subdivision Agreements and Amendments 6
- 2 by-laws assuming developed roadways and services
- 10 by-laws pursuant to the *Drainage Act*
- 6 regulatory by-laws (including Procedure By-law)
- 7 by-laws to adopt policies
- 5 by-laws to authorize borrowing (temporary, *Drainage Act*, and Denis St. Pierre Waste Water Treatment Plant Expansion)
- 1 by-law to adopt the 2024 Budget
- 3 by-laws to authorize taxation (interim 2024, final 2024 and interim 2025)
- 1 by-law relating to grants

- 3 by-laws relating to user fees
- 6 by-laws relating to appointments or delegation of authority, including the appointment of Councillor Hoffman – Ward 2
- 21 by-laws confirming the proceedings of Council meetings.

This is an average of 9 by-laws per month.
