Recommendation

The following individuals are appointed Business Improvement Area Board of Management for the term of Council or until their successors are appointed and subject to each person maintaining eligibility:

Jay Coulter, Ryley Gwilliam, Moe Mailloux, Charlie Maitre, Kristy Osborne, Lynn Pike, Sarah Regan, Tina Roy, Cole Rymerson, Shawn Sauve, and Travis Turkington.

Background

Section 204 of the *Municipal Act, 2001* provides that municipalities may establish business improvement areas for the designate an area as an improvement area and may establish a board of management,

- a) to oversee the improvement, beautification and maintenance of municipallyowned land, buildings and structures in the area beyond that provided at the expense of the municipality generally; and
- b) to promote the area as a business or shopping area.

In 2007, Council approved By-law 94-2007 (Attachment A) which established the current business improvement area and the Board of Management. Section 3 of By-law 94-2007 establishes the composition of the Board and section 4 establishes the term of office for Board members:

- 3. The Board shall consist of no less than seven members, at least one of whom shall be a member of Council and the remaining members shall be appointed by Council, based upon the recommendation of a majority of the members of the Area, and shall be persons qualified to be members of the Area as determined in accordance with Section 204 of the *Municipal Act, 2001*.
- 4. Each member of the Board shall hold a term concurrent to the term of Council, provided such persons continue to be qualified as provided in Section 3, above. Notwithstanding the foregoing each member of the Board shall continue to hold office until such time as their replacement is appointed.

For clarity, section 204 of the Municipal Act, 2001 provides the following:

Composition

- (3) A board of management shall be composed of,
 - (a) one or more directors appointed directly by the municipality; and
 - (b) the remaining directors selected by a vote of the membership of the improvement area and appointed by the municipality.

Membership

(4) Members of an improvement area consist of persons who are assessed, on the last returned assessment roll, with respect to rateable property in the area that is in a prescribed business property class and tenants of such property.

Subsequent to this confirmation, the BIA Coordinator submitted a revised letter to be presented to Council, which has been included as Attachment B to this report. It is noted that, should Council wish to expand the BIA area, an amendment to By-law 94-2007 would be required and would involve a comprehensive public consultation process.
