## By-law 10-2023

### Being a By-law to Authorize Grants by the Municipality of Lakeshore for 2023

**Whereas** pursuant to section 107 of the *Municipal Act, 2001*, S.O. 2001, c. 25, the Council may pass by-laws for grants to certain bodies for purposes in the interest of the Municipality;

**And whereas** the Council of the Municipality of Lakeshore deems a grant to the bodies named in this by-law to be in the public interest;

**And whereas** Council adopted the 2023 budget on February 14, 2023 thereby approving grants to the organizations described in Schedule "A" to this by-law;

#### Now therefore the Council of the Municipality of Lakeshore enacts as follows:

- 1. The Municipality authorizes the grants, both financial and in-kind grants, including goods, services or commodities, to the bodies as described in Schedule "A" to this by-law. The grants shall be in the form and amount specified in column B of Schedule "A".
- 2. The Municipality's Corporate Leader Chief Financial Officer, in consultation with the municipal solicitor, is authorized to execute any agreement, amendment thereto or other documentation to set out the terms and conditions of the grants.
- 3. The Corporate Leader Chief Financial Officer may advance all or part of the grant at such time or from time to time, as the Corporate Leader Chief Financial Officer determines to be appropriate after evidence has been provided to the Corporate Leader Chief Financial Officer that the conditions upon which the grant have been issued are satisfied.
- 4. This by-law shall be known as the "2023 Grants By-law".
- 5. Schedule "A" forms part of this by-law.
- 6. This By-law comes into force and effect upon passage.
